### TO REGISTER

#### To register as a shareholder

Select 'Shareholder', enter your SRN or HIN and select the country of your residence. If Australia, also enter your postcode.

Only shareholders are eligible to ask questions. To ask a question select the 'Q & A' icon, select the topic your question relates to. Type your question into the chat box at the bottom of the screen and press 'Send'.

To ask a verbal question, follow the instructions on the virtual meeting platform.



### Vote

## TO VOTE

When the Chair declares the poll open, select the 'Vote' icon and the voting options will appear on your screen.

To vote, select your voting direction. A tick will appear to confirm receipt of your vote.

To change your vote, select 'Click here to change your vote' and press a different option to override.



### Documents

To view meeting documents select the 'Documents' icon and choose the document you wish to view.
